## SG-1 Lighting Education and Information (R. White)

Verbal report from M. Bassett.

R. Jennings replied to a question regarding a survey taken of the need and availability of lighting testing laboratories in Canada. A report will probably be presented before the fiscal year (March '84) with three major findings:

- 1) there is a requirement for a testing facility
- 2) there is a requirement for a research facility
- 3) there is a need for a degree granting institute to offer Illumination Engineering in its curriculum or on lighting seminars to be put on across Canada.

With the completion of item 6 members broke for a short lunch.

### 7. Matters Raised by CIE Central Bureau

Circular letter No. 350 CN requested information regarding the arrangements for the  $\overline{\rm XX}$  Session. Discussion centred upon the following:

- (1) Information available before the Session.

  It was agreed that this was very well organized.
- (2) General arangements during the sessions.

  It was felt that not enough side rooms were available.

  Suitable rooms were required for small meetings for technical or national committees and often the only available space was the cafeteria.
- (3) Photographic Exhibition.

  This was thought to be extremely good.
- (4) Arrangements regarding speakers.

The availability of preprints or abstracts well in advance of the XX Session was a big help. Authors were required to have camera ready material available well in advance in order to publish the proceedings. This made it extremely costly to individual authors and it was wondered if a less rigid format could be followed. Figures were required to accompany the text. It would be easier on the author if figures could be placed together at the end of the written material.

### 7. Matters Raised by CIE Central Bureau Continued.....

- (5) Conference Arrangements.

  Contributed papers were a big improvement over the last few Sessions.
- (6) Poster Presentations.
  More physical space is required between presentations.
  The crowded noisy conditions created too many distractions.
- (7) Technical Committees. These were well run with access to good facilities. A minor complaint was that some agendas were missing.
- (8) Technical Visits and Social Events.
  Excellent.

The Secretary was instructed to convey these viewpoints to the Central Bureau.

### 8. CIE XX Session Amsterdam 1983

This item was mainly covered under item 7.

The members wished the minutes to record their vote of thanks to Prof. R. White for his work in organizing the Canadian poster display at the XX Session.

### 9. Reorganization of CNC/CIE to Accommodate New CIE Division Structure

Under the new reorganization the work of the 26 different technical committees is now carried out in 7 Divisions. Prior to the annual meeting Canada had only nominated representatives to 4 of the Divisions. Namely:

Division 1 P. Kaiser
Division 2 A. Robertson
Division 3 R. Jennings
Division 4 B. Tansley

Members were reluctant to volunteer for the other three Divisions mainly because of the cost of travel to two Division meetings during the quadrennium. G. Wyszecki explained the role of a Division Delegate, that they form a managerial committee, rather than a technical committee. Their role is to help select and appoint experts to the various working committees, and to monitor activities. Each Canadian Division Delegate should develop an advisory committee, perhaps made up of former TC members.

# 9. Reorganization of CNC/CIE to Accomodate New CIE Division Structures

### Continued.....

A Delegate could also be involved directly in the work of one or more technical committees. Although there can be only one official representative in each Division for each country, it is possible to have unofficial representatives. Attendance at international Division meetings, although obviously desirable, is not essential. In light of these explanations, the following volunteered.

- Division 3 G. Mulvey, as a replacement for R. Jennings who feels he may have to resign as Division Delegate because of future work commitments.
- Division 4 A. Ketvirtis, as an unofficial representative.
- Division 5 D. Trotter, to fill a vacancy.
- Division 6 G. Szeker, to fill a vacancy.
- Division 7 No member nominated to date. M. Bassett will approach R. White to see if he will allow his name to stand.
- D. Trotter will forward the names of the division members to Alec Fisher, Technical Chairman of CIE, with copies to the Central Bureau and W. Budde.

# 10. Appointments and Reappointments to the Executive Committee of the CNC/CIE

- M. Bassett reviewed two items of the By-Laws of the CNC/CIE, namely:
- (#6) There shall be not less than five and not more than nine members of the EC/CNC/CIE. They shall be appointed by the National Research Council. The CNC/CIE may recommend candidates for appointment. All members of the EC/CNC/CIE shall automatically be members of the CNC/CIE.
- (#18) All officers and members shall normally finish their terms of office at the end of the year during which a quadrennial Session of the CIE takes place, with the exception of members of the EC/CNC/CIE whose terms of office shall normally be four years but shall be staggered to provide continuity. All officers and members shall be eligible for immediate re-appointment.

Discussion ensued as to recommendations for appointment to the EC/CNC/CIE. The proposed slate is as follows:

By-Laws may be amended by an affirmative vote of a simple majority of the total membership of the CNC/CIE at a meeting or by letter ballot provided that notice of motion has been given at least two months before the date of the meeting or the closing date of the letter ballot. Notice of motion was given at the annual meeting by M. Bassett.

### 13. Other Business

 ${\tt M.}$  Bassett asked members for suggestions on how to revitalize CNC/CIE. Some suggestions were:

inviting younger people presently active in lighting to join CNC/CIE; issuing a newsletter with contributions from CNC/CIE members telling of Canadian lighting matters. This matter will be readdressed once the new Division structure is in working order. Members are asked to solicit ideas to the Executive for consideration.

D. Trotter asked if someone from NRC would look after publications. When a new publication is announced the Secretary writes CISTI and tells the number to order. Once the order has been received, the Secretary receives one free copy, and then announces that the publication is available. To date no copies have been received although orders were placed a year ago. It was felt that better liaison could be maintained if publications were handled by a CNC/CIE member in Ottawa. M. Rea volunteered to look into the problem of procedure. D. Trotter will supply M. Rea with details.

There being no further business the meeting adjourned at 4:15 p.m.

# CIE Executive Committee Report

December 2, 1983

Background information relating to the nominees for members of the Board of Administration, nominees for Division Directors, 1982 financial account statements and the draft budget for 1984-1987 were forwarded to the CNC/CIE in the spring of 1983 in preparation for the Executive Committee Meetings to be held at the CIE 20th Session in Amsterdam. Various proposals for re-location of the Central Bureau were also received.

Two meetings of the Executive Committee took place at Amsterdam; the first was on Tuesday, August 30th and the second Saturday, September 3rd. The following items were discussed:

- 1. The proposed new Statutes and By-Laws which had been circulated to the National Committees for approval were confirmed by the Executive Committee with only some minor changes in wording.
- Five new membership applications were approved: Hong Kong,
   Pakistan, Mexico, Brazil and Peru.
- 3. Reports were presented by the President, Secretary and the Chairman of the Action Committee on their activities during the quadrennium.
- 4. Three issues of the new CIE Journal have been published and delegates to the 20th Session received bound copies of the proceedings at the start of the conference. Publication will now be handled by Hungary.

- 5. There were long and heated discussions at the first meeting on the re-location of the Central Bureau. The final decision was made at the second meeting. A compromise solution was agreed to for the next four years: the Central Bureau will be located in Canada with Mr. Budde as the Executive Secretary. During this time the Board of Administration will investigate a more permanent solution with the Central Bureau hopefully located in Europe.
- 6. The new officers for the next quadrennium were unanimously elected as follows:
